It was indeed a pleasure speaking with you this evening. As promised, enclosed is the audio cassette containing Chuck Harder's version of what happened to the credit story.

If you do write to Harder (and I hope you do) to correct his misinformation, which has on several occasions been broadcast over 80 or so radio stations across the U.S. and internationally on shortwave, I would appreciate receiving a copy of your letter. His new address can be found at the conclusion of his letter on p. 7 of our Winter '90-'91 issue.

As we discussed, I am also sending you the issues of our newsletter in which we have reported upon Harder and his claims relative to UFOs and the like. As I have told him repeatedly, I believe that he is doing his audience a tremendous disservice with his one-sided presentation of unproven claims.

I presently have a wealth of information relating to Harder and his pro-paranormal crusade, including two of "For The People's" UFO-related magazines (see photocopies of covers), a voluminous written correspondence, and more than four hours of edited audio tapes of his radio programs. I have heard him mention that his readership now approaches 50,000, double the figure mentioned only months before his crusade commenced.


Because of your personal interest in UFOs, I am also enclosing an issue of Philip Klass' "Skeptics UFO Newsletter." Klass, the renowned Aviation Week magazine reporter and editor, and the world's premier UFO skeptic, has done scores of radio and TV interviews (including "Nightline" several years ago), and would no doubt enjoy hearing from you. I have heard on Harder's show that ABC-TV is working on a new series, slated for airing this spring, called "America's Best Kept Secrets," similar to NBC's "Unsolved Mysteries." I have also heard that ABC (perhaps as part of this series) is preparing a one-hour show on UFOs, presumably pro-paranormal.

If you or any newsperson at ABC is interested in pursuing these matters further, I would be delighted to welcome you to my home in sunny St. Pete. to review my files. Alternatively, as most of my family lives in the Baltimore area, I can travel to Washington during my next trip north, possibly this spring.
